

## EDITORIAL POLICY AND INSTRUCTIONS FOR AUTHORS

ACTA ICHTHYOLOGICA ET PISCATORIA (AI&P) is an international, peer-reviewed scientific journal that publishes articles based on original experimental data or experimental methods, or new analyses of already existing data, in any aspect of ichthyology and fisheries (fin-fish only).

We favour articles with an innovative approach, innovative interpretation, interesting justification of the research, and most of all, well fitting into the mainstream science. Such papers should constitute a step in a logical development of a subject and set new pathways for future research. We avoid accepting papers that are “isolated” (i.e., not linked to the “past” and “future” science). Manuscripts not fitting into the above-mentioned description (even those done perfectly in terms of methodology) are promptly rejected on the grounds of insufficient scientific priority.

We discourage the practice of reporting results of a single study in two or more manuscripts (“salami science”). For detail and exceptions see <http://www.councilscienceeditors.org/files/scienceeditor/v21n6p200.pdf>.

AI&P is issued on paper and in electronic form at <http://www.aiep.pl> (the journal is primary paper). The paper version appears four times a year. The electronic version is freely available on the internet (Open Access Journal).

It is expected that investigators running experiments on live fish, and intending to publish their results at AI&P, will have obtained an approval of a local ethic committee for scientific experiments on animals or any other local animal care committee. Authors of any papers dealing with threatened species should demonstrate that the fish were sampled legally and that the studies had an objective important for conservation of the species.

**Review process.** Advancement of fisheries science is the major requirement in the evaluation process of AI&P. Preliminary suitability of manuscripts is determined by editors or members of the Editorial Advisory Board and submissions with insufficient scientific priority are rejected promptly. Manuscripts not prepared in the advised style will be rejected without review. All other submissions are registered and the authors are notified (by e-mail) with the reference number, that **must be quoted** in subsequent correspondence. The registered manuscript is forwarded to one of our Associate Editors (subject editors) who sends it to two independent experts for scientific evaluation.

**Conflict of interests.** Authors of research articles evaluating or examining commercial products (e.g., fish feeds, anaesthetics, drugs, vaccines, etc.) should disclose to the editor, at the time of submission, any financial arrangement they may have with the manufacturer of such product or with the company making a competing product. It is expected that: 1) authors of such articles will not have any financial interest in the company (or its competitor) that makes the product discussed in the article; or 2) such arrangements will be in a clear form communicated to the reader.

All persons involved in the evaluation process (reviewers, members of the Editorial Advisory Board, editors) must report to the Editor-in-Chief any conflict of interest with regard to a manuscript under review or commercial companies involved with a product under study.

**Permissions.** Any material borrowed from other sources must be accompanied by a written statement from both the author and the publisher giving permission to AI&P for reproduction. It is assumed that authors citing unpublished data, and/or personal communications have obtained permission from all persons involved.

**Copyright transfer.** Upon acceptance of manuscripts, the authors convey, and otherwise transfer all rights, title, interest, and copyright ownership in said work to the West Pomeranian University of Technology in Szczecin (WPUTS)—owner of this journal. Consequently, any material from published (or accepted) articles cannot be published without the prior written permission of the WPUTS.

**Disclaimer.** The data and opinions appearing in the articles and advertisements herein are the responsibility of the author. Accordingly, the Publisher and the Editor accept no liability whatsoever for the consequences of any such inaccurate or misleading data, opinion, or statement.

**Printing costs and reprints.** The publishing costs of the AI&P are covered by the Publisher (Societas Scientiarum Stetinensis—SSS). The authors do not pay per-page charges. The only exception is the costs of colour pages (in 2011 the cost price one colour page was 300 PLN (=100 USD)). The authors obtain free PDF file that can be downloaded from our web page. A set of 25 reprints is offered to authors on preferential prices (depending on the number of pages). Higher numbers of reprints must be negotiated on individual basis.

### PREPARATION OF MANUSCRIPTS

Submissions are only **electronic** ([editor@aiep.pl](mailto:editor@aiep.pl)). Preferable format is .doc (optionally accompanied by a pdf file). **Please do not send docx files.** The manuscripts submitted electronically should be arranged in a way facilitating their transfer to reviewers and the evaluation process itself (single file, with figures and tables pasted into the text). The overall size of such manuscript should permit its subsequent distribution to reviewers. Revised, MSs, should be prepared in the same way, but in addition they should be accompanied by all illustrations saved as separate files (please note that Tables are not illustrations). Oversized files (over 20 MB) should be sent via a suitable Internet service such as Dropbox.

The submission must be accompanied by a cover letter stating that 1) All authors of the paper have directly participated in the planning, execution, or analysis of this study; 2) All authors of the paper have read and approved the final version submitted; 3) The contents of this manuscript have not been copyrighted or published previously; 4) The contents of the manuscript are not now under consideration for publication elsewhere; 5) The contents of the manuscript will not be copyrighted, submitted, or published elsewhere, while acceptance by this Journal is under consideration; 6) All directly related manuscripts, published by any author of this paper are cited in references (including conference abstracts).

**The text.** The manuscript should be arranged according to the following pattern: **title** (please use capital letters only when needed), **names** of authors (with first names spelled out, middle names as initial, and last name CAPITALIZED), **affiliations** of all authors (with e-mail addresses), up to **8 key words**, detailed mailing **address** of the corresponding author with the phone and fax numbers, and e-mail address, **running title, structured summary, Introduction, Materials and methods, Results, Discussion, Acknowledgements, References, tables, and figures.** Figure captions (including full legend describing the figure and explaining all the symbols used) must be pasted below respective figures (do not repeat them). An excess of headings and subheadings should be avoided. Only generic and specific names should be set in italics. Any issue not covered by the present instruction should be resolved based on “The scientific style and format”. The CBE Manual for Authors, Editors, and Publishers. Sixth Edition 1994, Cambridge University Press. All fish names must be consistent with the FishBase <http://www.fishbase.org> (except for taxonomic papers, which are free to challenge FishBase concepts).

**The summary** should be divided into small chapters: **Background** (Why the study was initiated? Why this type of study is needed? and What is the aim of the present paper?), **Material and methods, Results, principal Conclusion** (with closing remarks—What is the importance of the present findings? and What directions it sets for future research?) Please note that the Conclusion is **not a summary of the results**, but a more general statement. While writing the summary please keep in mind that it may be also reprinted separately by abstracting/indexing journals or databases. In **research notes** a short conventional **abstract** should be written instead of a structured summary. **Tables** must be self-explanatory, contain synthesized (not primary) data, and not exceed A4 size. Data shown on graphs should not be repeated in tables and vice versa.

**Figures.** Figures. Only well reproducible figures can be published. Excessive illustrative material should be avoided. Colour figures will be printed on author’s expense and therefore any colour pictures should be arranged in plates fitting into the page size of AI&P (width 16 cm). Colour illustrations will be published free of charge only in the electronic version of the journal (pdf files). Submitted manuscripts should have illustrations pasted into the text saved in a format taking up little space and permitting easy transfer to reviewers. Revised manuscripts must be accompanied by high-resolution figures. The resolution of photographs must be 300 dpi at print size (original extension: .jpg or .tif). Line art pictures (.tif extension) (maps etc.) must be done electronically (not scanned!) and their resolution must be 600 dpi at print size. The plots must be vectorized using “Adobe Illustrator” or “Corel Draw”. In vector graphics, the required parameters are: 1) picture width: 16 cm; 2) line thickness: 0.15 mm (or 0.25 pts); 3) letter size: 7–9 points (We prefer 9 pts but in some situations you will need smaller font.); 4) Colour declaration: CMYK (with black = 100%; or K = 100%) (**NOT RGB!**); 5) preferable extension: “.ai”.

**References** in the text should be quoted by the author’s name and date (in parentheses). When the author’s name is cited in parentheses please do not separate the name and the year with coma. If there are more than two authors,

only the first one should be mentioned, followed by “et al.” **DOI numbers** must be appended to those cited references that have them (please compare the most recent issue of AI&P). Please note that major publisher have been applying DOI numbers retroactively, so they may be not visible on papers reprints you have. In order to get all DOIs we need, please consult electronic versions of the papers you cite. When you determine a DOI you can verify it using <http://dx.doi.org/>. The reference list at the end of the paper should follow the examples shown below:

#### CONFERENCE ABSTRACT:

Internal reports, unstable web pages, or theses (BSc, MSc, or PhD) can only be included as footnotes. Please limit the number of cited conference abstracts, textbooks, etc. If possible “personal communications” should be avoided. The titles of papers published in languages other than English, French, German, or Spanish should be accompanied by their English translation [in brackets] and their original language should be stated [in brackets]. Names, paper titles, and journal names, originally written in non-Latin alphabets, should be transliterated (not transcribed) following ISO standards. For example Cyrillic alphabet should be transliterated following the ISO-86 system (Commonly used the Library of Congress System is in fact a national transcription system and as such cannot be accepted).

**Abbreviations and symbols.** Quantities should be expressed in SI units, although usage of units such as  $\mu\text{L}$  or L for liquids is acceptable (and suggested). All abbreviations should be spelled out when first used in the text.
